DECREE SETTLING FIRST AND FINAL ACCOUNT
AND PETITION FOR DISTRIBUTION

ROWENNA WALKER and MARGUERITE McBRIDE, Joint Administra-
trices C.T.A. of the Estate of PEARL GRIFFIN, Deceased, having
on the 28th day of March, 1969, rendered and filed herein a full
account and report of their administration of said Estate, as
well as that of DONALD GRIFFIN, prior Executor of said Estate,
according to records on hand (though not required), which said
Account was for a final settlement, and having with said Account
filed a Petition for the final distribution of said Estate, and
hearing on said Account and Petition having been set for the 8th
day of April, 1969, at the hour of 10:00 A.M., and having come
on for hearing on the 16th day of April, 1969, at the hour of
10:00 A.M., and proof having been made to the satisfaction of the
Court that due and legal notice of the settlement of said Account
and the hearing of said Petition for Distribution had been given
as required by law and the Order of this Court;

THE COURT HEREBY FINDS:

1. That the First and Final Account is in all respects
true and correct and that said Account is supported by proper
vouchers.

1 3. That said Joint Administratrices C.T.A. posted bond,
2 pursuant to the Order of this Court, in the sum of \$3,000.00.

3 4. That all Creditors' Claims duly filed and approved
4 in said Estate have been paid in full.

5 5. That the funeral expenses and costs of last illness
6 have been paid.

7 6. That all taxes of every name or nature required to
8 be paid by Decedent's Estate have been paid.

9 7. That WILSON and WILSON, Attorneys for said Estate,
10 have an agreed fee for its services, with the Joint Administra-
11 trices C.T.A., in the sum of \$3,044.10, which is a reasonable fee.

12 8. That the firm of WILSON and WILSON, as said
13 Attorneys, has advanced the sum of \$57.00 as costs of adminis-
14 tration and will incur necessary closing costs in the sum of
15 \$26.50 in connection with the Estate of JAMES J. GRIFFIN, and
16 said firm is entitled to be reimbursed therefor.

17 9. That the firm of WILSON and WILSON, as said
18 Attorneys, has advanced the sum of \$87.43 as costs of admini-
19 tration and will incur necessary closing costs in the sum of
20 \$29.00 in connection with the Estate of PEARL GRIFFIN, and said
21 firm is entitled to be reimbursed therefor.

22 10. That the Joint Administratrices C.T.A. have waived
23 payment of commissions from the Estate.

24 11. That the Appraisers, FRED B. HARRIS, HUGH D.
25 McMULLEN and JAMES M. OLIN, have not been paid their fees herein
26 or for the appraisal in the Estate of JAMES J. GRIFFIN, Deceased.
27 That there be allowed, from the over-all appraisal bill, the sum
28 of \$100.00 to each of said Appraisers, in full for services to
29 the Estate of JAMES J. GRIFFIN and the Estate of PEARL GRIFFIN,
30 to be paid from monies on hand herein, and that such is a reason-
31 able sum to be paid to each of said Appraisers.

1 12. That all of the property of Decedent was her
2 separate property. That pursuant to the terms of Decedent's Will,
3 since JAMES J. GRIFFIN predeceased Decedent, all of the properties
4 of the Estate available for distribution should be distributed,
5 share and share alike, unto ROWENNA WALKER, MARGUERITE McBRIDE,
6 and RUTH GRIFFIN, as the Administratrix of the Estate of DONALD
7 GRIFFIN, Deceased, excluding only the property described in the
8 Petition for Distribution as Parcel 2 of property owned by
9 Decedent and not a part of the partnership assets, said Parcel 2
10 being lots and improvements situate in the Townsite of Jarbidge,

25 WHEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED

26 A. That due and legal notice of the hearing of said
27 First and Final Account and Petition for Distribution was given
28 as provided by law. That the First and Final Account of said
29 Joint Administratrices C.T.A. be, and the same hereby is finally
30 settled, allowed and approved.

31 B. That the agreed fee of \$3,044.10 be allowed and

15 services to said Estate.

16 F. That there be allowed and paid unto FRED B. HARRIS,
17 HUGH D. McMULLEN and JAMES M. OLIN, Appraisers, the sum of
18 \$100.00 each.

19 G. That JOHN H. WALKER performed work for Griffin
20 Bros. partnership during the administration of said Estates;
21 however, he waived any payment for same in Open Court and,
22 accordingly, no payment for said services shall be allowed.

23 H. That the accounting of ALLEN T. GRIFFIN, the
24 surviving partner in possession of the partnership property
25 of Griffin Bros., be, and the same hereby is ratified, approved
26 and confirmed, subject to any subsequent Order of the Court
27 made necessary by examination of the final written accounting
28 to be filed herein.

29 I. That all interested parties having waived their
