1999 AFFIDAVIT AND NOTICE OF INTENT TO HOLD


Golden Trend Resources Inc. certifies as follows:


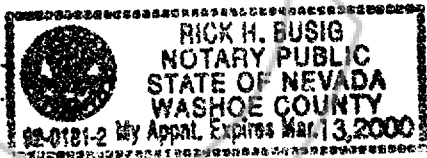

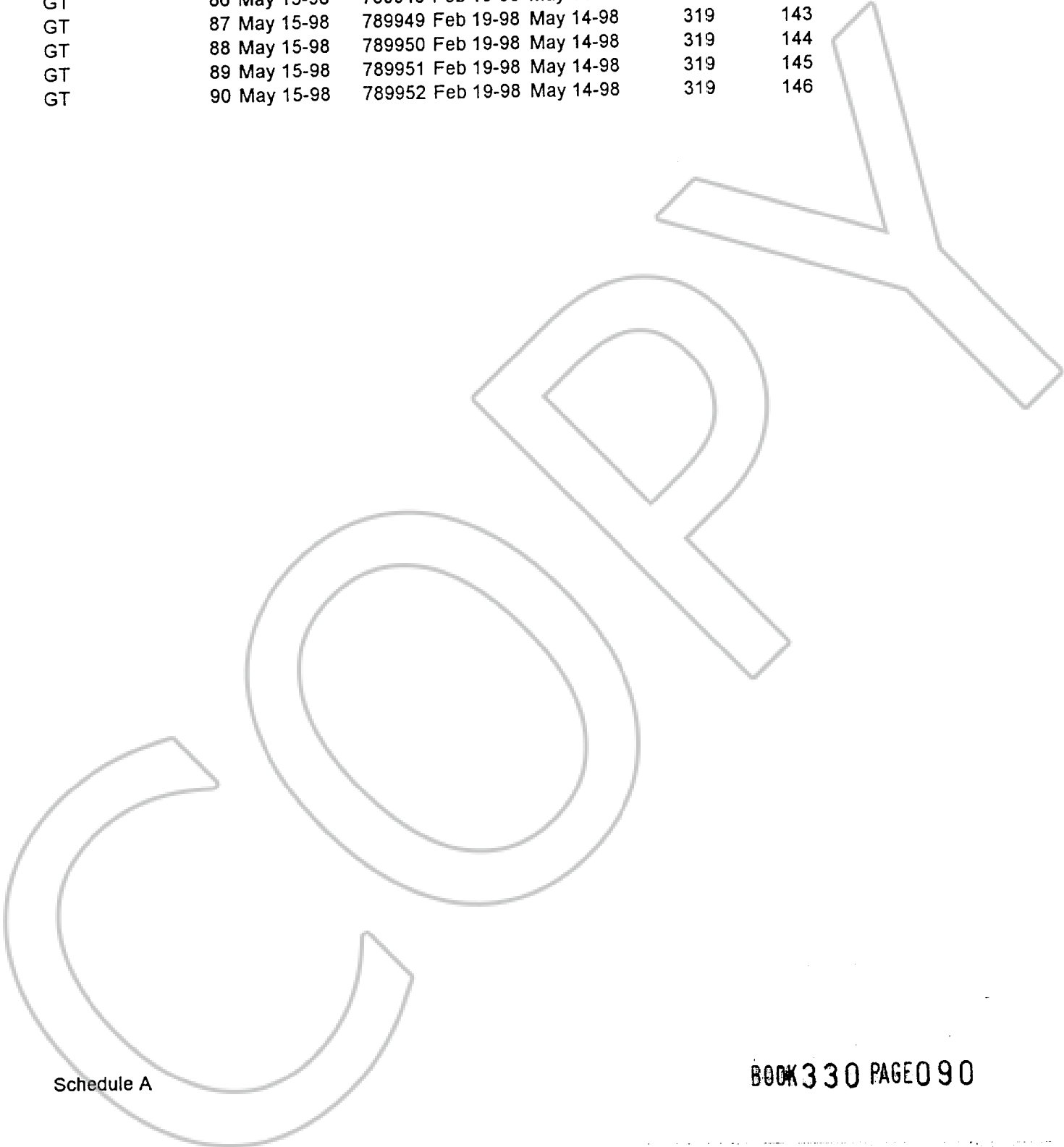
