
It is the intention of Santa Fe to maintain and develop the Claims as is provided for by law, and to hold the same to and through 11:59 a.m., September 1, 1999.

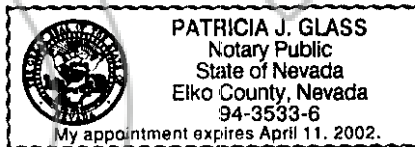
