
Richard J. Moorhead, first being duly sworn, deposes and says:

It is the intention of Newmont to maintain and develop the Claims as is provided for by law, and to hold the same to and through 11:59 a.m., September 1, 1999.

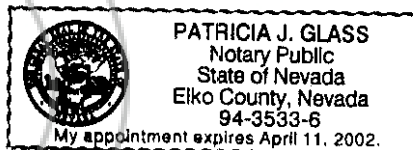
