19 of Plaintiff for Default Judgment, that the above-entitled Court
20 has jurisdiction over the Plaintiff, HACKWORTH DRILLING, INC., and
21 the Defendant, CORNELIUS HYZER, and in the subject matter contained
22 in the Plaintiff's Complaint; and, it further appearing that the
23 named Defendant has been duly and personally served with a copy of
24 the Summons and Complaint in this action as required and directed
25 by law more than twenty (20) days prior hereto; that the
26 above-named Defendant has not appeared herein by answer, motion or

2 pleading has expired, AND GOOD CAUSE APPEARING THEREFOR,

3 IT IS HEREBY ORDERED that the Default of the Defendant,
4 CORNELIUS HYZER, be and the same is hereby entered by the Court.

5 IT IS FURTHER APPEARING TO THE COURT:

6 1. That Plaintiff is entitled to Default Judgment
7 against the Defendant, CORNELIUS HYZER, and that Defendant is
8 indebted to the Plaintiff in the sum of \$4,407.88 for drilling
9 services, for which Defendant has failed and refused to pay.

10 2. That Plaintiff is entitled to a reasonable attorney
11 fee in the sum of \$1,470.00, together with court costs incurred to
12 date of \$137.00 and court costs to be incurred by Plaintiff in
13 connection herewith.

14 3. That Plaintiff is entitled to interest on the sum of
15 \$4,407.88 at the rate of nine and three-quarters percent (9.75%)
16 per annum from September 22, 1999, until paid.

17 NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND
18 DECREED that the Plaintiff have judgment against the Defendant,
19 CORNELIUS HYZER, as follows:

20 1. Principal sum of \$4,407.88.

21 2. For interest on the principal sum of \$4,407.88 at
22 the statutory rate of nine and three-quarters percent (9.75%) per
23 annum from the date of September 22, 1999, until paid.

24 3. The sum of \$1,470.00 as and for reasonable attorney
25 fees.

26 4. Court costs incurred of \$137.00, together with all
