IT IS FURTHER APPEARING TO THE COURT:

- 1. That Plaintiff is entitled to Default Judgment against the Defendant, CORNELIUS HYZER, and that Defendant is indebted to the Plaintiff in the sum of \$4,407.88 for drilling services, for which Defendant has failed and refused to pay.
- 2. That Plaintiff is entitled to a reasonable attorney fee in the sum of \$1,470.00, together with court costs incurred to date of \$137.00 and court costs to be incurred by Plaintiff in connection herewith.
- 3. That Plaintiff is entitled to interest on the sum of \$4,407.88 at the rate of nine and three-quarters percent (9.75%) per annum from September 22, 1999, until paid.

NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the Plaintiff have judgment against the Defendant, CORNELIUS HYZER, as follows:

- 1. Principal sum of \$4,407.88.
- 2. For interest on the principal sum of \$4,407.88 at the statutory rate of nine and three-quarters percent (9.75%) per annum from the date of September 22, 1999, until paid.
- 3. The sum of \$1,470.00 as and for reasonable attorney fees.
