Corner No. 4, the SW Corner, is a 2"x2"x4' wooden post marked "SW GAP 19"

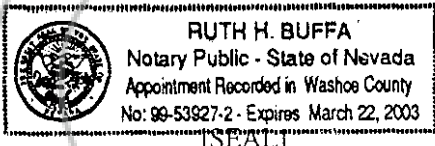
