hereby gives notice that the Owner of the unpatented lode mining claims listed on Exhibit "A" (attached hereto and made a part hereof) removed durable plastic pipe and replaced the monument of location and the corner monuments with wooden posts wherever durable plastic pipe had originally been used to mark the claims. Dimensions of the wooden posts are 2 inches by 2 inches (1-1/2 inches by 1-1/2 inches finished lumber) at least 4 feet in length and the posts were set 1 foot in the ground pursuant to the requirements of Assembly Bill No. 178 (amending NRS 517.030) authorizing the locators of certain lode mining claims to remove durable plastic pipe used to define the boundaries of the claims and to replace the pipe with valid legal monuments.

For the name of the claim(s), the book and page number(s) or the document number(s) of the Certificate of Location or the most recent amendment to the Certificate of Location, the book and page number(s) or the document number(s) of the map filed pursuant to NRS 517.040, see Exhibit "A". Said replacement of durable plastic pipe and this recording of notice does not (a) amend or otherwise affect the legal validity of the claim for which the monuments were created, (b) modify the date of location of the claim, or (c) require the filing of an additional or amended map pursuant to NRS 517.040.
