Marshall James Stenton	20%
Neil Douglas Stenton	20%
Kenneth Packard Stenton	20%
Frederick George Stenton	20%
David Stenton	10%
Ronald Stenton	10%

3. That the co-executors are hereby authorized to execute a Substitution of Trustee and Full Reconveyance to cause the removal of the deed of trust dated January 2, 1980 and

1 amended deed of trust on the property set forth in the deeds of trust upon receipt and distribution  
2 of the funds necessary to pay off the note;

3 4. That any property interest of the decedent of the estate in any other property  
4 subsequently discovered shall be and hereby is distributed as set forth in paragraph 2 of this  
5 Order; and

6 5. That upon completion of the foregoing that this estate be, and the same is hereby  
7 closed and that MARSHALL JAMES STENTON and NEIL DOUGLAS STENTON, the co-  
8 executors herein, be, and they are hereby exonerated from any further liability or responsibility  
9 herein.
