**AMENDED CERTIFICATE OF LOCATION
State of Nevada Lode Claim**

The undersigned SILVER VIKING CORPORATION, a Nevada corporation having its principal place of business at 545 Sth Valley View Drive, #100, St. George, Utah 84770, certifies that it has amended the Grover Cleveland lode mining claim, more particularly described below. The original location was the 2 day of October, 1998. The original certificate of location was recorded in the Official Records of Eureka County, Nevada in Book 324 at page 496, and filed with the Bureau of Land Management under Serial Number NMC 798869. The date of amendment is the 12th day of July, 2000.

The number of linear feet used in length along the course of the vein, each way from the point of discovery, is 266 feet in northeast direction and 418 feet in a southwest direction. The width claimed on each side of center of the vein is 248 feet. The general course of the lode or vein, as near as may be determined northeasterly to southwesterly.

This lode mining claim is located in the SW¼ of Section 34, Township 19 North, Range 53 East, Mount Diablo Base & Meridian, Eureka County, Nevada.

This claim is contiguous and is bounded by the following claims: Antelope on the North; Diamond on the East; Lantern on the South; and Republic on the West.

The work of location consisted of making the maps provided in NRS 517.040.

Corner No. 3, the SE Cor., is a 2"x2"x4' wooden post marked "SE GROVER CLEVELAND"
Corner No. 4, the SW Cor., is a 2"x2"x4' wooden post marked "SW GROVER CLEVELAND"
