**ORDER TO TERMINATE
INTEREST IN COMMUNITY
PROPERTY**

1 1. Due and legal notice of the filing and hearing of the Petition was given.

2 2. All averments in the Petition are true and correct.

3 3. Petitioner is the surviving spouse of Robert O. Burnham, also known
4 as Robert Otto Buram.

5 4. Decedent died on May 15, 2000, as shown by the copy of Death
6 Certificate attached the Petition, survived by his spouse, the Petitioner, Elaine W.
7 Burnham.

8 5. Petitioner and Decedent were married on March 18, 1957, and
9 remained spouses ul Decedent's death.

10 6. On the 20th day of May, 1993, Petitioner and Decedent entered into
11 that certain written reement entitled Declaration of Manner of Owning Property (copy
12 attached to Petitionn which they agreed that all assets they owned then or in the future in
13 the name of one or th of them was their community property.

14 7. On the 20th day of May, 1993, Petitioner and Decedent executed that
15 certain Revocable list Agreement (copy attached to the Petition), in which they:

17 (a) created avocable, living trust of most of their assets called the Burnham Family
18 Trust;

20 (b) declared it all real and personal assets, tangible and intangible, in which they
21 had any present or ure right, title or interest, whether located within or outside Nevada,
22 was held by them a rustees of the Burnham Family Trust; and

24 (c) agreed tl all community property transferred to the Trust would retain its
25 character as commuty property.

1 8. The assets that were on May 20, 1993 declared by Petitioner and
2 Decedent to be held by them, then and in the future, as Trustees of the Burnham Family
3 Trust as community property, included the following (Property):

4 the Exhibit A attached hereto and made a part hereof.)

5 9. At the time of Decedent's death, the ownership of, and title to all assets
6 held by Petitioner and Decedent as Trustees of the Burnham Family Trust as community
7 property, including the Property described on Exhibit A, vested in Petitioner, Elaine W.
8 Burnham, as the surviving Trustee of the Burnham Family Trust, AND GOOD

10 CAUSE APPEAR THEREFOR,

11 IT IS HEREBY ORDERED, ADJUDGED AND DECREED PURSUANT
12 TO NRS 40.525, AS FOLLOWS:

13 1. All right, title and interest of Decedent in and to all Property on Exhibit
14 A attached hereto and the same hereby is, terminated at his death on May 15, 2000; and

15 2. The same vested in Elaine W. Burnham as Trustee of the Burnham
16 Family Trust on May 15, 2000.
