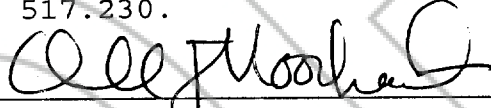
Richard J. Moorhead, first being duly sworn, deposes and says:

I am the duly authorized agent of Newmont Mining Corporation, a Delaware corporation ("NEWMONT"), and am personally acquainted with the matters described herein.

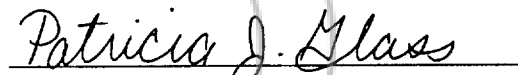

It is the intention of NEWMONT to maintain and develop the Claims as is provided for by law, and to hold the same.

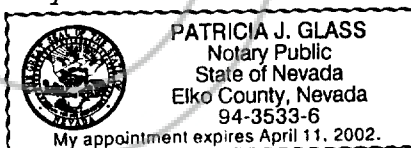
