## FIRST AMENDMENT

### TO

### AMENDED A) RESTATED MINING VENTURE AGREEMENT

This First Amendent to Amended and Restated Mining Venture Agreement ("First Amendment") is ade and effective as of the <u>13</u> day of April, 2000, among Placer Cortez, Inc., a Diware corporation ("PCI") and Kennecott Explorations (Australia) Ltd., a Delare corporation ("KEA") as the Participants in the Cortez Joint Venture and Placer Doi U.S. Inc., a California corporation, ("PDUS") as Manager of the Cortez Joint Ventur

#### Recitals

PCI, PDUS and IA are parties to that certain Amended and Restated Mining Venture Agreement (the oint Venture Agreement"), executed as of the 29<sup>th</sup> day of October, 1999, but madiffective as of January 1, 1998.

Section 3.2 of thoint Venture Agreement provides that the name of the Venture shall be the Cortez Join enture.

Pursuant to Secti 2.3 of the Joint Venture Agreement, title to the Assets shall be held in the name of 1 Cortez Joint Venture.

The Cortez Jointenture has in the past conducted, and is currently conducting, its operations, in part, uer the fictitious name of Cortez Gold Mines.

A fictitious namertificate has been recorded in Eureka and Lander Counties, Nevada, specifying that Cortez Joint Venture is doing business as Cortez Gold Mines.

For good and vaible consideration, the receipt and sufficiency of which are hereby acknowledged, I, PDUS and KEA agree to amend the Joint Venture Agreement as follows:

#### Agreement

- 1. <u>Amendme of Agreement</u>. The first sentence of Section 2.3 of the Joint Venture Agreement share deleted in its entirety and replaced with the following:
  - 2.3 Rerd Title. Title to the Assets shall be held in the name of t Cortez Joint Venture or Cortez Gold Mines.
