
WHEREAS, Assignor desires to assign and convey 50% of his 10% leasehold interest in the East Tomera ranch Prospect.



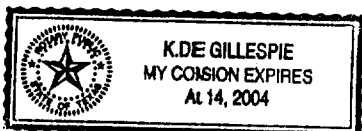
