Should I, for any reason, fail to designate such new beneficiaries, this tr shall terminate upon my death and the trust property shall revert to my estate.

In the ev. of my death or legal incapacity, I hereby nominate and appoint as Successor Trustee herever the beneficiary above-named, unless such beneficiary should for any reason be legally incoment or otherwise fail to serve as such, in which event I hereby nominate and appoint as alternate accessor Trustee(s) hereunder:

- 6. This Decation of Trust shall extend to and be binding upon the heirs, executors, administrators, and assis of the undersigned and upon the Successors to the Trustee.
  - 7. The True and his or her successors shall serve without bond.
- 8. This Decation of Trust shall be construed and enforced in accordance with the laws of the State of New.
- 9. I intend this Declaration of Trust also to destroy any right of survivorship in the property which is the suct of this Declaration, and to convert my interest therein to a tenancy in common.
