**DEED OF CORRECTION**

THIS INDENTURE made and entered into as of the 6<sup>th</sup> day of March, 2001, by and between, NEWMONT MING CORPORATION, a Delaware corporation, formerly known as NEWMONT GOLD COMPANY, (hereinafter "NEWMONT"); and COUNTY OF EUREKA, a political subdivision of the State of Nevada, (hereinafter "COUNTY") with reference to the following facts:

**RECITALS:**

WHEREAS, by Grant, Bargain and Sale Deed, dated September 30, 1992, and recorded at Book 239, Page 379 of Office Records, as Document No. 142583, Eureka County Recorder's Office, NEWMONT conveyed a certain parcel of land to Eureka County Fire Protection District, as Grantee; and,

WHEREAS, NEWMONT and COUNTY desire to clarify and correct certain errors contained in said Deed and further desire that such clarifications and corrections relate back to the time of said Deed; NOW THEREFORE

**WITNESSETH:**

That NEWMONT, Grantor, in consideration of the sum of Ten Dollars, lawful money of the United States of America to it in hand paid by COUNTY, as Grantee, on behalf of the Eureka County Fire Protection District, the receipt whereof is hereby acknowledged, does by these presents, grant, bargain, sell, convey and confirm unto COUNTY, and to its successors and assigns, all that certain real property situated in the County of Eureka, State of Nevada, described as:

A parcel of land located in Section 25, Township 33 North, Range 48 East, MDM, Eureka County, Nevada, as shown as Parcel No. 2 on that certain Parcel Map for Newmont Gold Company, filed in the Office of the Eureka County Recorder, Eureka, Nevada, on August 1, 1992, as File Number 142001,

so long as, and only so long as said property is used for public fire protection purposes, and not for other purposes. In the event said property is not used for public fire protection purposes, title to the same shall revert to NEWMONT, the Grantor, its successors and assigns.

RESERVING unto NEWMONT, and its successors and assigns, all minerals, of whatever kind and name, including, but not limited to, ores, metals, industrial minerals, coal, oil, gas and other hydrocarbons, geothermal resources and related mineral substances and the use of the surface as is necessary to extract the same.

TOGETHER WITH the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

SUBJECT TO any and all exceptions, reservations, restrictions, restrictive covenants, assessments, easements, rights, and rights of way of record.

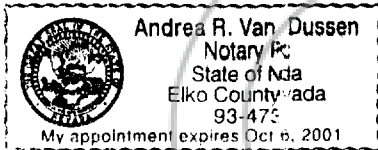
