**CONVEYANCE OF ROYALTY INTEREST**

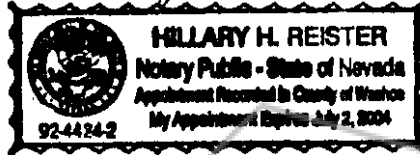
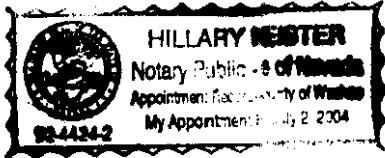
