The due and legal notice to the taxpayers was given by publication in the Eureka Sentinel, a newspaper published for circulation in the Town and County of Eureka, State of Nevada, and by notice forwarded by mail to the taxpayers as required by law, giving the taxpayers notice of the amounts due and the date of delinquency.


That said taxes on the properties herein described not having been paid within the specified time according to law and the notice sent out, became delinquent after the first Monday in March, 1999.

That the names of the taxpayers, with the assessor's Parcel Number upon which taxes have not been paid, with the value of the property assessed, and the amount due for the taxes were entered in the delinquent list of said Eureka County for the taxable year 1998-1999 on the 3rd Monday in March, 1999.

That the said County Treasurer, within 30 days after the first Monday in March, 1999, advertised according to law, in the Eureka Sentinel, a newspaper published for circulation in the Town and County of Eureka, State of Nevada, said properties with the name of the owner to whom said property was assessed, and the amount thereon due, with Assessor's Parcel Number, within the time allowed by law, the Tax Receiver or her successor in office to make to the County Treasurer as Trustee for the State and County a deed of the properties.

That said taxes and costs not having been paid as required by law, the Tax Receiver did, in pursuance with said notice, issue a deed to said properties and improvements as heretofore mentioned, together with and singular the tenements, hereditaments and the appurtenances thereunto belonging or in anywise appertaining.

TO HAVE AND TO HOLD and singular the said premises, together with the appurtenances unto said Grantee as True, for said Eureka County, State of Nevada, and her successor in office.
