**CERTIFICATE OF LOCATION OF LODE MINING CLAIM**

TO ALL WHOM IT MAY CONCERN:

The undersigned person hereby certifies that it has located the JR# 189 lode mining claim in Section(s) 25, 36 Township 26 North, Range 48 East, Mount Diablo Base and Meridian, in the unknown Mining District, County of Eureka, State of Nevada.

The claim is 10 feet in length and 600 feet in width, and 1480 feet is claimed in a North direction and 20 feet is claimed in a South direction from the location monument upon which the notice of location is posted, together with 300 feet on each side of the center of the claim. The general course of the lode deposit and premises is from the South to the North.

The position of each corner of this claim is shown on the mining claim map recorded herewith. The monument position and markings on each corner monument is as follows:

The monumentations and marking of the above described corners on the ground was completed within 60 days from the date of posting the notice of location; and the location work consisted of making and recording of duplicate claim maps and payment of the fees prescribed by NRS 517.040.
