

CERTIFICATE OF LOCATION OF LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

The undersigned locator hereby certifies that it has located the **JR# 212** lode mining claim in Section(s) **36**, Township **26** North, Range **48** East, and Section(s) **1**, Township **25** North, Range **48** East, Mount Diablo Base and Meridian, in the **unknown** Mining District, County of **ureka**, State of Nevada.

The claim is **15** feet in length and **600** feet in width, and **1480** feet is claimed in a **South** direction and **20** feet is claimed in a **North** direction from the location monument upon which the Certificate of Location is posted, together with **300** feet on each side of the center of the claim. The general course of the lode deposit and premises is from the **North** to the **South**.

As erected on the ground, each corner monument consists of a wood post 2"x2"x4' in length set 1 foot in the ground, and is marked as described above with a tag affixed to the monument post. The monumentations and marking of the above described corners on the ground was completed within 60 days from the date of posting the notice of location; and the location work consisted of making and recording of duplicate claim maps and payment of the fees prescribed by NRS 517.040.
