**CERTIFICATE OF LOCATION OF LODE MINING CLAIM**

TO ALL WHOM IT MAY CONCERN:

The undersigned locator hereby certifies that it has located the JR# 214 lode mining claim in Section(s) 36, Township 26 North, Range 48 East, and Section(s) 1, Township 25 North, Range 48 East, and Section(s) 1, Township 25 North, Range 48 1/2 East, Mount Diablo Base and Meridian, in the unknown Mining District, County of Eureka, State of Nevada.

The claim is 15 feet in length and 600 feet in width, and 1480 feet is claimed in a South direction and 20 feet is claimed in a North direction from the location monument upon which the notice of Location is posted, together with 300 feet on each side of the center of the claim. The general course of the lode deposit and premises is from the North to the South.
