ADDITIONAL TERMS AND CONDITIONS

Construct & maintain a Type 4 approach for approximately ten vehicles per day onto SR-306 (Crescent Valley Road) and a half miles north of Crescent Valley, Nevada.

1. Permittee shall notify the District Engineer 48 hours prior to beginning construction within N.D.O.T. right-of-way.
2. PERMITTEE shall perform all work within the highway right-of-way in accordance with the State of Nevada "Standard Specifications for Road and Bridge Construction", 1996 edition & "Standard Plans", 1999 edition. (U. OF METRIC UNITS IS WAIVED)
3. Permittee shall observe applicable safety regulations in accordance with the "Manual on Uniform Traffic Control Devices"
4. Permittee shall perpetuate roadway drainage by placing two twenty-four inch pipes in the approach at the flat bottom ditch the right-of-way.
5. Permittee shall place and maintain a "STOP" sign at the approach.
6. Permittee shall not place trailers on N.D.O.T. right-of-way.
7. Permittee shall, at their own cost should traffic warrant in the future, be responsible for upgrading the approach and SR-306 (Crescent Valley Road), as directed by the N.D.O.T. District Engineer, (roadway widening, enlarging approach, street lights, curb, gutter, sidewalk, striping, etc.).

This Right-of-Way Occupancy permit is granted to the PERMITTEE in accordance with the provisions of Chapter 408 NRS, and subject to the terms and conditions stipulated to perform the work described.
