

ROYALTY DEED

This Royalty deed (this "Deed") is made and effective as of the 11th day of May, 2001, by JoAnn Wreisner Curtis, a married woman who holds the property to be conveyed as her separate property, and whose address is 4410 Interlaken Ct., Reno, NV 89509 ("Grantor") and Timothy K. Wilson, a single person, whose address is 2240 Sari Drive, Reno, NV 89509, and Gregory A. Wilson, a single person, whose address is 1475 Autumn Hills Drive, Reno, NV 89511, ("Grantees").

RECITALS AND DEFINED TERMS

Grantor owns royalty interests in mining claims in the Eureka District (organized), in Eureka County, Nevada, which claims are listed on Exhibit A, attached hereto and incorporated herein for all purposes (the "Mining Claims"), and wishes to give and convey her Royalty Interests (hereinafter defined) in equal shares to her two children, being the Grantees named above.

All of the rights, privileges, powers and interests conveyed or bestowed upon the grantors or the grantees under the above Assignments, Royalty Deeds and Supplemental Royalty Deeds, as modified, amended or limited by the above Agreements and Partial Relinquishment, Release and Reduction of Overriding royalty are hereinafter referred to, in the aggregate, as the "Royalty Interests". Grantor wishes to convey all of the Royalty Interests in equal shares to the Grantees, to be held as the separate property of each grantee.

II. CONVEYANCE

In consideration of the love and affection which Grantor bears for the grantees, Grantor hereby gives, bargains, sells and conveys each of the individual Grantees, their respective legal representatives, heirs, successors and assigns, as to separate property of each Grantee, an undivided one-half (1/2) of the Royalty Interests, such interests to be held by each Grantee as his separate property. This Deed also conveys any rights which Grantor may hold to receive royalty interests in mining claims which might be acquired subject to area of interest provisions which may

pertain to the royalty Interests by virtue of the various deeds, assignments, conveyances and agreements listed above. This Deed shall also convey to the Grantees any rights to after-acquired title to the Royalty Interests which may be obtained or held by Grantors.

The provisions of this Deed shall be binding upon and shall inure to the benefit of Grantor and Grantees and their respective successors, assigns, personal representatives and heirs.

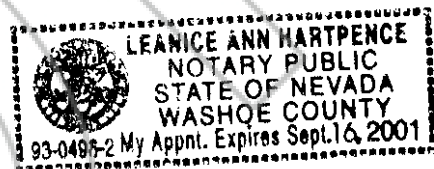
