## ERTIFICATE OF RELOCATION OF LODE CLAIM

THIS IS TO CERT( that the J-74 Lode Mining Claim was relocated by Windfall Venture, Colorado general partnership, whose post office address appears below, on the 5th day of June, 2001. The original J-74 Lode Mining Claim was located by Windíl Venture on May 6, 1980, and was recorded in Book 84 at Page 392 of the Offial Records of the County Recorder of Eureka County, Nevada and bore BLM Serial mber NMC 160224, and was subsequently allowed to lapse for failure to pay annuarental fees.

The general cove of the lode or vein is northerly and southerly. The claim is situate in the Reo Canyon portion of the Eureka (unorganized) Mining District, Eureka Covy, Nevada.

The Locator clas 20 feet in a northerly direction and 1480 feet in a southerly direction om the location monument, and a width of 300 feet on each side of the center  $\epsilon$  the vein or lode along the entire length of the claim.

In compliance th NRS Sections 517.040, 517.050 and other applicable portions of NRS, a n was prepared and recorded with the Eureka County Recorder.

A new location nument was erected at the time of location, and the corner monuments of the orinal claim were adopted by Windfall Venture. Each such adopted corner is meed with a valid legal monument (as described in NRS 517.030), consistinof 4" x 4" wooden posts or securely capped 4" aluminum pipe, at least 4 feet lon set one foot of its length in the ground, said posts being located and marked follows:

"NW COR J-74 thence N 70° E for a distance of 600 feet to a post marked, "NE COR J-74 thence S 20° E for a distance of 1500 feet to a post marked, "SE COR J-74 thence S 70° W for a distance of 600 feet to a post marked, "SW COR J-74 thence N 20° W for a distance of 1500 feet to the NW Corner of this clai the point of beginning.

This claim li within an unsurveyed portion of T. 17 N., R. 53 E., MDB&M, Eureka County, Neva. The NW corner of this claim is approximately 3,950 feet south and 15,280 ft west of the NW Corner of Section 6, T. 17 N., R. 54 E. Although the townso in which this claim lies is unsurveyed, by protracting the section lines of t adjacent townships it appears that this claim will be within the SW 1/4 of Secta 3, T. 17 N., R. 53 E., MDB&M, Eureka County, Nevada.

All work neceary to complete this relocation has been performed by September 19, 2001 Dated this 19th day of September, 2001.
