## CERTIFICATE OF RELOCATION OF LODE CLAIM

THIS IS TO CERTIFY that the J-83 Lode Mining Claim was relocated by Windfall Venture, Colorado general partnership, whose post office address appears below, on the 26th day of June, 2001. The original J-83 Lode Mining Claim was located by Windfall Venture on May 8, 1980, and was recorded in Book 84 at Page 397 of the Official Records of the County Recorder of Eureka County, Nevada and bore BLM Serial Number NMC 160229, and was subsequently allowed to lapse for failure to pay annual rental fees.

The general course of the lode or vein is northerly and southerly. The claim is situated in the Rio Canyon portion of the Eureka (unorganized) Mining District, Eureka County, Nevada.

The Locator class 20 feet in a southerly direction and 1480 feet in a northerly direction from the location monument, and a width of 300 feet on each side of the center of the vein or lode along the entire length of the claim.

In compliance with NRS Sections 517.040, 517.050 and other applicable portions of NRS, a map was prepared and recorded with the Eureka County Recorder.

A new location monument was erected at the time of relocation, and the corner monuments of the original claim were adopted by Windfall Venture. Each such adopted corner is marked with a valid legal monument (as described in NRS 517.030), consisting of 4" x 4" wooden posts or securely capped 4" aluminum pipe, at least 4 feet long set one foot of its length in the ground, said posts being located and marked as follows:

"NW COR J-83 thence N 70° E for a distance of 600 feet to a post marked,  
"NE COR J-83 thence S 20° E for a distance of 1500 feet to a post marked,  
"SE COR J-83 thence S 70° W for a distance of 600 feet to a post marked,  
"SW COR J-83 thence N 20° W for a distance of 1500 feet to the NW Corner of this claim the point of beginning.

This claim lies within an unsurveyed portion of T. 17 N., R. 53 E., MDB&M, Eureka County, Nevada. The NW corner of this claim is approximately 250 feet north and 16,800 feet west of the NW Corner of Section 6, T. 17 N., R. 54 E. Although the township in which this claim lies is unsurveyed, by protracting the section lines of adjacent townships it appears that this claim will be within the NW 1/4 of Section 3, T. 17 N., R. 53 E., and the SW 1/4 of Section 34, T. 18 N., R. 53 E., MDB&M Eureka County, Nevada.

All work necessary to complete this relocation has been performed by September 19, 2001 Dated this 19th day of September, 2001.
