
Thomas M. Roesch first being duly sworn, deposes and says:

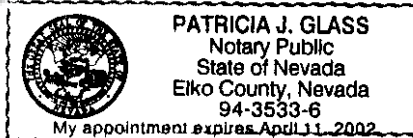
