
Thomas M. Roesch First being duly sworn, deposes and says:


It is the intention of NEWMONT to maintain and develop the Claims as is provided for by law, and to hold the same.

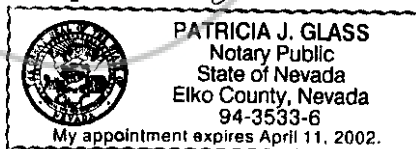
