## ASSIGNMENT OF MINERAL RIGHTS LEASE

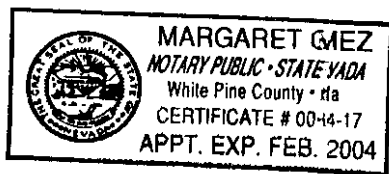
