CERTIFICATE OF LOCATION

NOTICE IS HEREBY GIVEN that BARRICK GOLDSTRIKE MINES INC., 293 Spruce Road, Elko, Nevada 89801-4491, hereby claims under and pursuant to the laws of the state of Nevada and of the laws of the United States of America the following described LODE MINING CLAIM:

The name of the claim is the GA FRAC 18.

The claim was located on OCTOBER 17, 2001, by posting a Location Notice at the discovery monument found at, on, or near the SOUTH end of the claim.

The length of the claim is 1480 feet in a NORTH direction and 20 feet in the opposite direction from the monument where the Location Notice is posted, and the width is 100 feet on each side of the center of the vein or lode comprising all 1500 feet in length and 200 feet in width, and generally following a NORTH-SOUTH course.

The exterior boundaries are distinctly marked by four substantial monuments of wooden posts at least 1-1/2 inches in diameter by four feet in length, set one foot in the ground, one at each corner. The boundaries can be readily traced by beginning at corner No. 1, the Northeast corner:

- thence S 01°02'2E feet 1500 to the SE corner, corner No. 2,
- thence S 88°57'3W feet 200 to the SW corner, corner No. 3,
- thence N 01°02'2W feet 1500 to the NW corner, corner No. 4,
- thence N 88°57'3E feet 200 to the NE corner, corner No. 1, the point of beginning.

The corner monuments have aluminum tags attached, scribed with claim name and corner number.

The northeast corner of this claim, corner No. 1, is found about N 01°36'21" E, 2668.83 FEET from the S 1/4 corner of section 14 Township 36N, Range 49E, M.D.M.

Said claim is located in the:  
NE 1/4 of section T36N R49E,  
SE 1/4 of section T36N R49E,  
SW 1/4 of section T36N R49E,  
NW 1/4 of section T36N R49E,  
M.D.M., EUREKA county, State of Nevada.

The boundaries of said claim were defined by law within sixty days from the date of posting of the Notice of Location. The location was consisted of the making and filing of maps and payment of fees prescribed by NRS 517.040, was completed by the date of recordation of this certificate.
