The Claim is approximately 0 feet long and approximately 600 feet wide, such that 1490 feet is claimed in a northeasterly direction (approximately 042 degrees) and 10 feet is claimed in a southwesterly direction (approximately 222 degrees) in the point of discovery (monument of location), at which the Notice of Location is posted, together with 300 feet each side of the monument of location and centerline of the claim. The general course of the vein and these rises is northeast and southwest.
