The applicant **Gate General Improvement District** hereby makes application for permission to change (Point of Diversion, Manner of Use, and Place of Use for a portion of water heretofore appropriated under Permit No. 24214, Certificate 8174

1. The source of water **Underground**
2. The amount of water to be changed **0.01 CFS and 6.72 AFA**
3. The water to be used **Quasi-Municipal**
4. The water heretofore permitted for **Irrigation and Domestic**
5. The water is to be diverted at the following point **within the SW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 28, T.20N., R.53E., M.D.B.&M. at a point from which the SW corner of said Section 28 bears S. 00° 27' 17" W. a distance 1,138.37 feet. (Refer to Map supporting Permit No. 64117)**
6. The existing permit point of diversion is located within **SW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 17, T.20N., R.53E., M.D.B.&M., at a point from which the West $\frac{1}{4}$ corner of said Section 17 bears S. 45° 00' 00" W. a distance of 141.42 feet. (Refer to Map supporting Application No. 63164)**
7. Proposed place of use **portion of the SE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 29, T.20N., R.53E., M.D.B.&M. (Refer to Map supporting Permit No. 64117)**
8. Existing place of use **W $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 17, T.20N., R.53E., M.D.B.&M. (1.680 acres – refer to Map supporting Application No. 63164)**
9. Use will be from **January 1st to December 31st** of each year.
10. Use was permitted from **April 1st to September 30th** of each year.
11. Description of proposed works **Drilled well, pump, and pipelines to the place of use**
12. Estimated cost of works **\$165,000**
13. Estimated time required to construct works **Work Completed**
14. Estimated time required to complete the application of water to beneficial use **5 years**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same subject to the following limitations and conditions:

This permit to change the point of diversion, place of use and manner of use of a portion of the waters of an underground source as heretofore granted under Permit 24214, Certificate 8174 is issued subject to the terms and conditions imposed in said Permit 24214, Certificate 8174 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permit 49924, Certificate 146, Permit 64117 and Permit 67902 shall not exceed 5.777 million gallons annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.01 cubic feet per second, but not to exceed 290 million gallons annually.
