THIS DEED, on this 13th day of October, in the year of Our Lord One Thousand Nine Hundred Forty-four (1944) between Charles F. Cook and Laurel E. Cook, husband and wife of Ordway, Crowley County, State of Colorado, parties of the first part, and Frank B. Cook, of Ordway, Crowley County, State of Colorado, party of the second part;

WITNESS,

That the said parties of the first part, for and in consideration of the sum of (\$10.00) Ten and no/100 Dollars and other good and valuable considerations, to them in hand paid, the said party of the second part; the receipt whereof is hereby confessed and acknowledged have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto said party of the second part, and unto his heirs, executors, administrators and assigns, forever, all those pieces or parcels of land situate, lying and being in the county of Elko and State of Nevada, hereby relinquishing and waiving all rights under and by virtue of the homestead exemption laws or statute and more particularly known and described as follows, to-wit:

Parcel The Southwest quarter (SW $\frac{1}{4}$) of Section Twenty-five (25) same Northeast Quarter (NE $\frac{1}{4}$) of section thirty-five (35), Township thirty-one (31) North, Range fifty-two (52) East, Mt Diablo Base and Meridian, containing 320 acres, more or less.

Parcel The Northwest quarter (NW $\frac{1}{4}$) of the Southeast quarter (SE $\frac{1}{4}$), Southwest quarter (SW $\frac{1}{4}$) of the Northeast quarter (NE $\frac{1}{4}$), the South half (S $\frac{1}{2}$) of the Northwest quarter (NW $\frac{1}{4}$) of Sect. 24 in Township 31 North, Range fifty-two (52) East, Mount Dio Base and Meridian, Nevada, containing 160 acres, according to the Official Plat of the Survey of the said Land.

Parcel The Southeast quarter (SE $\frac{1}{4}$) of Section Fourteen (14) in Township Thirty one (31) North, Range fifty-two (52) East, Mount Dio Base and Meridian, Nevada, containing 160 acres, according to the Official Plat of the Survey of the said Land.

Parcel All of Section Twenty-three (23); North Half (N $\frac{1}{2}$) and the South east Quarter (SE $\frac{1}{4}$) of Section Twenty-five (25); All of section thirty-three (33); Northwest Quarter (NW $\frac{1}{4}$) and the South West Quarter (SW $\frac{1}{4}$) of Section thirty-five (35), Township thirty-one (31) North, Range fifty-two (52) East, Mount Diablo Base and Merian, containing 2240 acres, more or less.

Parcel The North Half (N $\frac{1}{2}$) of the North Half (N $\frac{1}{2}$), the Southeast Quarter (SE $\frac{1}{4}$) of the Northeast Quarter (NE $\frac{1}{4}$), the East Half (E $\frac{1}{2}$) of the Southeast Quarter (SE $\frac{1}{4}$), and the Southwest Quarter (SW $\frac{1}{4}$) of Section Twenty-four (24) in Township Thirty-one (31) North, Range fifty two (52) East, Mount Diablo Base and Meridian, Nevada, containing 480 acres more or less.

TO HAVE AND HOLD the said above described premises unto the said party of the second part, administrators, executors, heirs and assigns forever. Together with the privileges, hereditaments and appurtenances thereunto in any wise appertaining or belonging.

And the said parties of the first part, for their heirs, executors and administrators do covenant and agree, to and with said party of the second part his heirs, executors, administrators, and assigns, that at the sealing and delivering of these presents there well seized in the said premises, in and of a good and indefeasible estate free simple. And that they are free from all incumbrances whatsoever.

And that they have good and lawful right to sell and convey the same, and that the said parties of the first part will and their heirs, executors and administrators shall WARRANT AND DEFEND the same against all lawful claims and demands whatsoever.

And the said parties of the first part, for their heirs, executors, and administrators do covenant and agree to and with the said party of the second part, his heirs and assigns that the said party of the second part, his heirs and assigns, shall and may lawfully at all times hereafter, peaceably and quietly have, occupy, possess and enjoy the said premises hereby granted, or intended so to be, with the appurtenances, without lawful hindrance or molestation of the parties of the first part, their heirs and assigns, or of any other person or persons whatsoever, by or with his or their consent, privily or procurement.

And the said Laurel E. Cook wife of the said Charles F. Cook upon the consideration aforesaid does hereby release and forever quit-claim unto the said party of the second part his heirs and assigns, all her rights of dower and homestead in and to the above named premises.
