7 against the Dendants, WESTERN IRRIGATION, INC., and MONTE BROWN,
8 and that Defdants are indebted to the Plaintiff in the sum of
9 \$2,589.11 for oncrete goods, materials, supplies and services, for
10 which Defendas have failed and refused to pay.

11 2. That Plaintiff is entitled to a reasonable attorney
12 fee in the suof \$850.00, together with court costs incurred to
13 date of \$141.00 and court costs to be incurred by Plaintiff in
14 connection hewith.

15 3. That Plaintiff is entitled to interest on the sum of
16 \$2,589.11 at e rate of twenty-four percent (24%) per annum from
17 January 4, 20, until paid.

26 3. The sum of \$850.00 as and for reasonable attorney
27 fees.

28 4. Court costs incurred of \$141.00, together with all

1 other legal costs to be incurred by Plaintiff in connection
2 herewith.
