AMENDED CERTIFICATE OF LOCATION OF LODE CLAIM

THIS IS TO CERTIFY that the INT 64 Lode Mining Claim was located on the 11th day of October, 1994 by Idaho Resources Corporation, whose mailing address is P. O. Box 2183, Grand Junction, CO 81502. Its Location Certificate was recorded on November 17, 1994 in Book 278 at Page 365 of the Official Records of Eureka County, Nevada. The BLM Serial Number assigned to his claim is NMC 706940.

The general course of the lode or vein is northerly and southerly. The claim is situate in the Red Hills (unorganized) mining district, Eureka County, Nevada.

The Locator claims 25 feet in a northerly direction and 975 feet in a southerly direction from the location monument, and a width of 50 feet on each side of the center of the vein or lode along the entire length of said claim. The size of the claim is approximately 1,000 feet long and approximately 100 feet wide.

In compliance with Section 517.040, 517.050 and other applicable portions of the NEVADA REVISED STATUTES, a map, which accompanied the original location certificate, was recorded with the said Eureka County Recorder. It is believed that this map accurately depicts the location of the claim on the ground, however an additional claim location map is being recorded with this Amended Location Certificate.

Each corner of this claim is marked with a 2" x 2" wooden post, with markings on aluminum tags as follows:

This claim lies mostly within the NW 1/4 of Section 18, T. 25 N., R. 50 E., MDB&M, Eureka County, Nevada, whereas it was described in its original Location Certificate as being in the NW 1/4 of Section 18, T. 25 N., R. 49 E. The NW Corner of this claim is approximately 730 feet south and 340 feet east of the NW corner of Section 18, T. 25 N., R. 50 E., MDB&M.

This AMENDED CERTIFICATE OF LOCATION is made for the purpose of correcting the above noted error, as well as any other errors, defects or omissions which might exist in the original location, description or record, and does not constitute a waiver of any rights acquired under or by virtue of said original location.
