The claim is 1500 f long and 600.00 feet wide and 10.00 feet is claimed in a S85°13'17"W direction along the length of claim and 1490 feet is claimed in a N85°13'17"E direction along the length of the claim from the Location Monument, a 1½" x 1½" x 4' long wood post, at which a Notice of Location is posted, together with 300.00 feet in width on each side of the center of the claim. The general course of the lode deposit, as can be determined at this time is in a N85°13'17"E and S85°13'17"W direction. The description of the claim is as follows:
