AMENDMENT TO FIRST AMENDMENT TO TRUST AGREEMENT

This amendment made this 13<sup>th</sup> day of September, 2002 in the City of Modesto, State of California, by and between Earl A. Rasmussen and Lavernia C. Rasmussen, as Settlers and as Trustees.

WHEREAS:

- 1] Settlers and Trustees duly executed a Trust Agreement on August 25, 1989;
- 2] Settlers and Trustees amended the Trust Agreement by a First Amendment to Trust Agreement on February 1, 1991.

NOW THEREFORE:

This Amendment to the "First Amendment to Trust Agreement" executed on February 1, 1991. The Amendment is as follows: Article 16. SUCCESSOR TRUSTEES of the First Amendment Trust Agreement is hereby replaced by an entirely new and different Article 16. SUCCESSOR TRUSTEES which reads as follows:

"16. SUCCESSOR TRUSTEES. It is our intention that this Trust should always be administered by Trustees who shall be required to agree before taking any action. Upon the death, incapacity or resignation of Earl A. Rasmussen, Lynda L. Robinett-Sales of Oakdale, Ca. shall become Successor Co-Trustee to serve in his place. Upon the death, incapacity or resignation of Lavernia C. Rasmussen, her daughter, Betty Ann Grasso, shall become Successor Co-Trustee to serve in her place. If Betty Ann Grasso is unwilling or unable to serve, then her daughter, Sandra Garrett, shall so serve. If Sandra Garrett is willing or unable to serve, David E. Rasmussen shall so serve. If David E. Rasmussen is unwilling or unable to so serve, then Gary Hall shall so serve."

- 4] All other provisions and terms in the "First Amendment to Trust Agreement" shall remain in full force and effect.

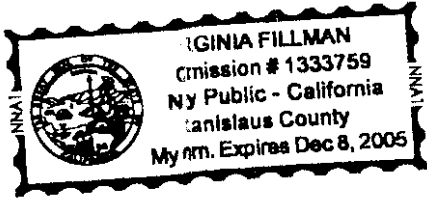

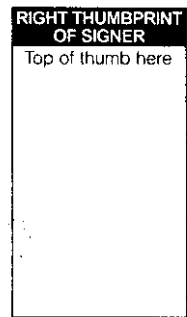
