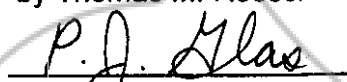
1. The maintenance was paid and the federal fee requirements were met for each of the Claim(s) for the assessment year ending September 1, 2002.

All such maintenance fees are paid on behalf of NEWMONT.

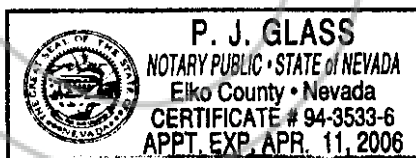
