CERTIFICATE OF LOCATION  
OF LODE MINING CLAIM

By this Declaration and such location, the above named locator(s) claim all veins, lodes, ledges, deposits and surface ground within the boundaries of said claim.

Said claim is distinctly marked on the ground so that its boundaries may be readily traced by four substantial posts or monuments, and is more particularly described as follows:
