# SORT FORM OF OPTION AGREEMENT

This SHORT RM OF OPTION AGREEMENT is made as of the 16th day of October, 2002 (the "Effective L\*"), by and among Tom and Volina Connolly, husband and wife, whose address is HC66 Box. Crescent Valley, Nevada 89821 (collectively, "Connolly") and Placer Dome U.S. Inc, a Calmia corporation, whose address for purposes hereof is HC 66 Box 1250 Crescent Valley, Neva 89821 ("PDUS").

#### RECITALS

- A. Connolowns the entire and undivided interest in and to the surface estate within certain fee lands locatin Eureka County, Nevada, as more particularly described on Exhibit A attached hereto and importated herein by reference (the "Property").
- B. Connol and PDUS have entered into an Option Agreement covering the Property dated effective tober 16, 2002 (the "Agreement").
- C. Connoland PDUS desire to enter into this Short Form of Option Agreement (the "Short Form") for purpose of placing of record a notice of the Agreement.

#### **AGREEMENT**

NOW THEREDRE, for good and valuable consideration, the receipt and sufficiency of which is hereby consed and acknowledged, Connolly and PDUS have agreed and do hereby agree as follow

- Grant option to Purchase the Property. Connolly has granted and hereby grants and leases excludly unto PDUS an option to purchase the Property together with all of the rights, privileges, a easements thereto incident or appurtenant (including, without limitation, any water. skwatering and reservoir rights associated with the Property and all easements and rights-ovay appurtenant thereto) (the "Option"). PDUS may exercise the Option at any time dur the period between the date of the Agreement and 5:00 p.m. Pacific time on October 16, 2f (the "Option Period").
- 2. <u>Activition the Property During the Period</u>. The Property is subject to a Mining Lease among the Jeane L. Bowman Trust, the Connollys and PDUS of even date with the Option Agreement, ancarsuant to that Mining Lease PDUS has certain rights to use the Property. In addition, suant to the Agreement, the Connollys have retained certain limited rights to use the Propertor grazing purposes.
- 3. <u>Success and Assigns.</u> The Agreement and this Short Form are, and shall be, binding upon and inure the benefit of the heirs, representatives, successors and assigns of the

parties thereto and anxird party acquiring any interest in the Property. No assignment by PDUS of any interest ler the Agreement or this Short Form shall be made without the prior written consent of the anollys, which consent shall not be unreasonably withheld. Notwithstanding the figoing, however, PDUS will not be required to obtain the Connolly's consent to any assignate of its interest in the Agreement to its affiliates or subsidiaries, or to the Cortez Joint Venta. In addition, no such consent shall be required in connection with a corporate reorganization merger or other consolidation involving PDUS, or a sale of all or substantially all of PD's assets, or in connection with the granting of a security interest in PDUS's interest in the reement.

- 4. <u>Right oirst Refusal</u>. Pursuant to the Agreement, for a period of time set forth in the Agreement, the Collys have granted and hereby grant to PDUS a right of first refusal to purchase the producticoyalty payable to the Connollys under the Agreement (the "Production Royalty"), if the Connol desire to sell all or any portion of their interest in the Production Royalty (subject to the hts of the Connollys to make certain assignments and conveyances for bona fide estate plannipurposes without triggering that right of first refusal).
- 5. Additio Terms. The Agreement contains clauses pertaining to the Production Royalty, the Connolly razing rights, and various other provisions, and reference is made to the Agreement for such of terms and conditions as govern the Agreement, which terms and conditions are by referre made a part hereof. Nothing in this Short Form shall limit or affect the rights and duties of parties under the Agreement. Information regarding the Agreement can be obtained from FJS at the address set forth above.
