## ORRECTION QUITCLAIM DEED

THIS CORF. TION QUITCLAIM DEED (this "Deed"), dated this /3/4 day of November, 2002 be effective as of March 10, 1995, is from BARRICK GOLDSTRIKE MES INC, a Colorado corporation, P.O. Box 29, Elko, Nevada 89803 ("Barrick"), to DEFA. RHOADS and SHARON RHOADS (the "Rhoads"), as Trustees of the Deand Sharon Rhoads Trust dated October 21, 1997 ("Trustees").

### RECITALS
