CORRECTION QUITCLAIM DEED

THIS CORRECTION QUITCLAIM DEED (this "Deed"), dated this 13~~th~~ day of November, 2002, be effective as of March 10, 1995, is from BARRICK GOLDSTRIKE M&S INC, a Colorado corporation, P.O. Box 29, Elko, Nevada 89803 ("Barrick"), to DEAN A. RHOADS and SHARON RHOADS (the "Rhoads"), as Trustees of the Dean and Sharon Rhoads Trust dated October 21, 1997 ("Trustees").

RECITALS

- A. Barrick and Rhoads entered into that certain Agreement dated February 25, 1995 (the "Agreement"), pursuant to which the parties agreed to exchange certain parcels of real property.
- B. Paragraph 10(a) of the Agreement provided the Rhoads to convey the real property and any improvements located thereon to Barrick and further provide
- "in the conveyance, the Rhoads will reserve all water rights with the right to transfer the same to other property...."
- C. Pursuant to the Agreement, the Rhoads delivered a Grant Bargain and Sale Deed dated March 10, 1995, and recorded on April 13, 1995 in the real property records of Eureka County as Entry No. 157557 in Book 282, page 88 (the "Conveyance"). An express reservation of water rights was inadvertently omitted in the Conveyance.
- D. This Deed is executed and delivered to correct the inadvertent omission of an express reservation of water rights and to reaffirm the reservation of water rights contained in paragraph 10(a) of the Agreement.

DEED

BARRICK, and in consideration of the sum of TEN DOLLARS (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, do hereby remise, release and forever quitclaim unto the Trustees, all right, title and interest in and to the water rights reserved by the Rhoads in paragraph 10(a) of the Agreement, said water rights being appurtenant to or related to the following described property

Towhip 35 North, Range 49 East MDB&M

Section 22: SW¼


Section 28: NE¼

TO HAVE AND TO HOLD the said water rights, unto the Rhoads and their successors, heirs and assigns forever.



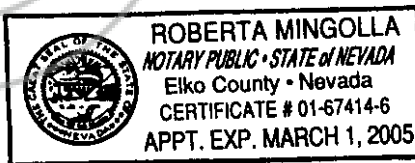
