The Claim is approximately 10 feet long and approximately 300 feet wide, such that 1190 feet is claimed in an easterly direction and feet is claimed in a westerly direction from the point of discovery (monument of location), at which the Notice of Location is posted, together with 150 feet on each side of the monument of location and centerline of the vein. The general course of the vein and these premises is north and south.
