AMENDMENT TO AGREEMENT AND EASEMENTS

THIS AMENDMENT is made effective as of August 1, 2002, between Newmont USA Limited, a Delaware corporation ("NEWMONT"), d/b/a Newmont Mining Corporation, and its subsidiary company, the Land and Livestock Company, a Nevada corporation ("ELLCO"), and the United States of America ("the USA").

RECITALS

WHEREAS, Newmont Mining Corporation, a Delaware corporation and its subsidiary company, ELLCO, entered into an Agreement and Deed of Conservation and Access Easements ("Agreement") with the USA dated September 27, 2000, which Agreement was recorded on November 1, 2000 in Book 338 at page 476 of the Official Records of Eureka County, Nevada;

WHEREAS, NEWMONT is successor through merger and name change to Newmont Mining Corporation;

WHEREAS, NEWMONT, ELLCO and the USA desire to amend the Agreement;

THEREFORE, for valuable consideration, NEWMONT, ELLCO and the USA agree to amend the Agreement as follows.

AGREEMENT

Section 1.6 Term of Easement to the Agreement is deleted in its entirety and replaced with the following:

"Section 1.6 Term of Easement. The Easement conveyed by this Article I shall terminate in the year 2120 or at such time as Maggie Creek flow augmentation required under the South Operations Area Project 1993 Environmental Impact Statement Mitigation Plan, if any, ceases, whichever is later; provided that in no event shall the term of this Easement extend beyond 2161."

Except as expressly amended hereby, the Agreement shall remain unaltered by this Amendment.

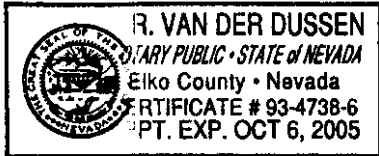

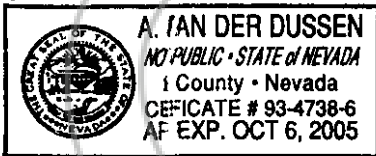

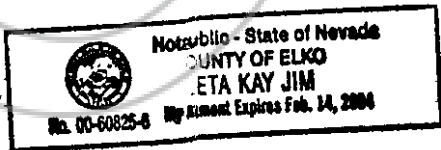
