

AMENDED NOTICE AND CERTIFICATE OF LOCATION

KNOW ALL MEN BY THESE PRESENTS, that Genesis Gold Corporation, having an address of #3 Knotill Road, Park City, Utah 84098, is the owner of the JR 132 lode mining claim, located DECEMBER 12, 1999, and hereby amends the original location by the placement of a copy of its Amended Notice and Certificate of Location on the location monument on the 19th day of December, 2002, under and by virtue of the mining laws and regulations of the United States and the State of Nevada.

The claim is located in the:

NW Section 31, Township 26N., Range 49E., M.D.M.

SW Section 30, Township 26N., Range 49E., M.D.M.

NE Section 25, Township 26N., Range 48E., M.D.M.

Section _____, Township _____ N., Range _____ E., M.D.M.

in an unmined Mining District, Eureka County, Nevada.

The claim is 1500 feet long and is 600 feet wide and 10 feet is claimed in a S87°06'E direction along the length of the claim and 1490 feet is claimed in a N87°06'W direction along the length of the claim from the Location Monument at which this Amended Notice and Certificate of Location is posted, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit, as can be determined at this time is in a S87°06' and N87°06'W direction. The description of the claim is as follows:

Begin at Corner No. 1, the Northeast Corner of the claim;

Thence 2°47'E, 600.63 feet to Corner No. 2, the Southeast Corner;

Thence 37°06'W, 1500 feet to Corner No. 3, the Southwest Corner;

Thence 2°47'W, 600.63 feet to Corner No. 4, the Northwest Corner;

Thence 37°06'E, 1500 feet to Corner No. 1, the Northeast Corner;
the place of beginning.

The original location work consisted of making a mining claim map as provided in Nevada Revised Statute 17.040. Two copies of an amended map are hereby filed in the records of Eureka County, Nevada.

The original location monument and corners are to be replaced with 1½" x 1½" x 4" wood posts set into a mound or mound of stone. The location and markings on each corner are scribed on an aluminum tag attached to each corner post as listed below:

The original monumentation was replaced and remonumented by the 19th day of December, 2002.

The original Certificate for this claim was recorded in Eureka County in Book 332 of the Official Records, Page 40. The claim was filed with the Nevada State Office of the Bureau of Land Management, receiving Federal Serial Number NMC 812681.

This Amended Notice and Certificate of Location is filed pursuant to N.R.S. 517.200 for the purpose of exercising the rights and privileges granted, and gaining the benefits conferred, thereby.
