The cla is 1500 feet long and is 600 feet wide and 1490 feet is claimed in a N 88°56' W direction along the length of the claim and 10 feet is claimed in a S 88°56' E direction along the length of the claim from the Location Monument at which this Amended Notice and Certificate of Location is posted, together with 300 feet in width on each side of the center of tclaim. The general course of the lode deposit, as can be determined at this time is in a N 88°56' and S 88°56' E direction. The description of the claim is as follows:

Beginn at Corner No. 1, the Northeast Corner of the claim;

Thence 2°37' E, 601.24 feet to Corner No. 2, the Southeast Corner;

Thence 88°56' W, 1500 feet to Corner No. 3, the Southwest Corner;

Thence 2°37' W, 601.24 feet to Corner No. 4, the Northwest Corner;

Thence 88°56' E, 1500 feet to Corner No. 1, the Northeast Corner;

The orral location work consisted of making a mining claim map as provided in Nevada Revised Statu 517.040. Two copies of an amended map are hereby filed in the records of Eureka County, Nava.

The orral location monument and corners are to be replaced with 1 1/2" x 1 1/2" x 4' wood posts set l' into ground or mound of stone. The location and markings on each corner are scribed on an aluminutag attached to each corner post as listed below:
