

NOTICE AND CERTIFICATE OF LOCATION
OF LODE MINING CLAIM, NEVADA

KNOWN ALLEN BY THESE PRESENTS, that Genesis Gold Corporation, having an address of #3 Knob Hill Road, Park City, Utah 84098 has located the JR 302 lode mining claim, in Eureka County in the State of Nevada, on the 20th day of December, 2002.

The claim is located in:

NW 1/4 Section 31, Township 26N, Range 49E, M.D.M.

The claim is 150 feet long and 400 feet wide and 10 feet is claimed in a EAST section along the length of the claim and 1490 feet is claimed in a WEST section along the length of the claim from the Location Monument at which a Notice of Location is posted, together with 200 feet in width on each side of the center of the claim. The general course of the lode deposit, as can be determined at this time is in a EAST and WEST direction. The description of the claim is as follows:

Begin: at Corner No. 1, the Northeast Corner of the claim;
 Thence SOUTH, 400 feet to Corner No. 2, the Southeast Corner;
 Thence WEST, 1500 feet to Corner No. 3, the Southwest Corner;
 Thence NORTH, 400 feet to Corner No. 4, the Northwest Corner;
 Thence EAST, 1500 feet to Corner No. 1, the Northeast Corner;
 the place of beginning.

The location of each corner of the claim is shown on the claim map that is filed herewith. The number, location & markings on each boundary or corner monument is as follows:

As erected on the ground each boundary or corner is marked as described above by an aluminum tag attached to the monument.

The monument and markings of the above mentioned corners on the ground was completed by the 20th day of December, 2002, and the location work consisted of making a claim map provided in NRS 517.040. Two copies of this map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the County Recorder.
