

# NOTICE AND CERTIFICATE OF LOCATION OF LODE MINING CLAIM, NEVADA

KNOWN ALLEN BY THESE PRESENTS, that Genesis Gold Corporation, having an address of #3 Knob H Road, Park City, Utah 84098 has located the JR 305 lode mining claim, in Eureka County in the State of Nevada, on the 20<sup>th</sup> day of December, 2002.

The claim is 100 feet long and 600 feet wide and 1490 feet is claimed in a N1°07'21"W section along the length of the claim and 10 feet is claimed in a S1°07'21"E section along the length of the claim from the Location Monument at which a Notice of Location is posted, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit, as can be determined at this time is in a N1°07'21"W and S1°07'21"E direction. The description of the claim is as follows:

Begin at Corner No. 1, the Northeast Corner of the claim;  
 Thence N1°07'21"E, 1500 feet to Corner No. 2, the Southeast Corner;  
 Thence S88°52'39"W, 600 feet to Corner No. 3, the Southwest Corner;  
 Thence N1°07'21"W, 1500 feet to Corner No. 4, the Northwest Corner;  
 Thence S88°52'39"E, 600 feet to Corner No. 1, the Northeast Corner;  
 the place of beginning.

The location of each corner of the claim is shown on the claim map that is filed herewith. The number, location and markings on each boundary or corner monument is as follows:

As erected on the ground, each boundary or corner is marked as described above by an aluminum tag attached to the monument.

The monumentation and markings of the above mentioned corners on the ground was completed by the 20<sup>th</sup> day of December, 2002, and the location work consisted of making a claim map provided in NRS 517.040. Two copies of this map have been filed with the Eureka County recorder, and the lode claim filing fee has been paid to the County Recorder.
