NOTICE AND CERTIFICATE OF LOCATION
OF LODE MINING CLAIM, NEVADA

KNOWN ALLEN BY THESE PRESENTS, that PLACER DOME US INC., having an address of HC 66 BX 1250, CRESCENT VALLEY, NEVADA, 89821 has located the WFM 16 lode mining claim, in Eureka County, in the State of Nevada, on the 7th day of November, 2002.

The claim is located in:

SE 1/4 Section 26, Township 26 N., Range 48E., M.D.M.
SW 1/4 Section 25, Township 26 N., Range 48E., M.D.M.
____ 1/4 Section _____, Township _____ N., Range 48E., M.D.M.
____ 1/4 Section _____, Township _____ N., Range 48E., M.D.M.

The claim is 10 feet long and 600 feet wide and 1490 feet is claimed in a North section along the length of the claim and 10 feet is claimed in a South section along the length of the claim from the Location Monument at which a Notice of Location is posted, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit, as can be determined at this time is in a North and South direction. The description of the claim is as follows:

Beginning at Corner No. 1, the Northeast Corner of the claim;
Thence South, 1500 feet to Corner No. 2, the Southeast Corner;
Thence West, 600 feet to Corner No. 3, the Southwest Corner;
Thence North, 1500 feet to Corner No. 4, the Northwest Corner;
Thence East, 600 feet to Corner No. 1, the Northeast Corner;
the place of beginning.

The location of each corner of the claim is shown on the claim map that is filed herewith. The number, location and markings on each boundary or corner monument is as follows:

No. 4: <u>Corner No. 4</u>	<u>NW Cor. WFM 16</u>	<u>1 1/2" x 1 1/2" Wood Post, 4' Long</u>

As erected on the ground, each boundary or corner is marked as described above by an aluminum tag attached to the monument.

The monumentation and markings of the above mentioned corners on the ground was completed by the 7th day of November, 2002, and the location work consisted of making a claim map as provided NRS 517.040. Two copies of this map have been filed with the Eureka County Recorder and the lode claim filing fee has been paid to the County Recorder.
