NOTICE AND CERTIFICATE OF LOCATION

The claim is 100 feet long and 400 feet wide and 1490 feet is claimed in a North section along the length of the claim and 10 feet is claimed in a South section along the length of the claim from the Location Monument at which a Notice of Locan is posted, together with 200 feet in width on each side of the center of the claim. The general course of the lode deposit, as can be determined at this time is in a North and Sci direction. The description of the claim is as follows:

Beginn: at Corner No. 1, the Northeast Corner of the claim;
Thence South _____, 1500 feet to Corner No. 2, the Southeast Corner;
Thence West _____, 400 feet to Corner No. 3, the Southwest Corner;
Thence North _____, 1500 feet to Corner No. 4, the Northwest Corner;
Thence East _____, 400 feet to Corner No. 1, the Northeast Corner;
the place of beginning.
