NOTICE AND CERTIFICATE OF LOCATION

The claim is 150 feet long and 300 feet wide and 1490 feet is claimed in a East \_\_\_\_\_ cction along the length of the claim and 10 feet is claimed in a West \_\_\_\_\_ cction along the length of the claim from the Location Monument at which a Notice of Locan is posted, together with 150 feet in width on each side of the center of the claim. The genl course of the lode deposit, as can be determined at this time is in a East and West direction. The description of the claim is as follows:

Beginning at Corner No. 1, the Northeast Corner of the claim;
